If symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered but only in conjunction with atropine.

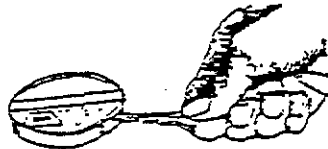

Use the baits [traps] on floors, under sinks, refrigerators, in storage areas, on shelves, in cabinets, or where ants have been seen. For best results, use several baits [traps] at the same time. Repeat as necessary for continuous control.]

READ INSTRUCTIONS BEFORE PRESSING IN PERFORATED HOLES.

Press in semi-perforated holes on side of bait [trap].



INDOORS: Use the baits [traps] on floors, under sinks, under refrigerators, in storage areas, on shelves, in cabinets, or wherever ants have been seen. For best results, place several baits [traps] at the same time. Repeat as necessary for continuous control.

OUTDOORS: Place bait [trap] near ant colonies and along trails. A reduction in activity should be noticeable within one week after trap placement.

EFFECTIVE CLEAN ECONOMICAL

STORAGE: Store in a cool, dry place (preferably locked) inaccessible to children and pets. Keep in original container.

DISPOSAL: Do not reuse container. Wrap in newspaper and dispose in trash.
