moderate eye injury.

Also replace the sentence:

Avoid contact with skin or eyes.

with the following:

Avoid contact with eyes, skin, or clothing.
Wash thoroughly with soap and water after
handling.

This statement should immediately follow the above statement.

Registration No. 1021-1577) was conditionally approved provided MCK submit
acute oral and dermal toxicity studies in support of their product.

Since this product is similar to the MGK product and is relying on MGK
Company's data, additional label changes may be required after EPA's review of

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product will kill cockroaches, confused flour beetles, crickets, fleas, houseflies, pill bugs, rice weevils, saw-toothed grain beetles, silverfish, small flying moths, spiders, ticks and wasps.

Cover exposed food, dishes and food-handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Put out all flames and pilot lights. Close doors and windows. Point valve opening away from face when releasing. Use one unit for each 6,000 cubic feet of unobstructed area. Use additional units for remove rooms or where free flow of mist is not assured. Do not remain in the area during treatment and ventilate thoroughly before reentry.

TO OPERATE: Place a stand or table on several layers of newspaper or a pad in the center of the room to be treated. To lock valve in open position for automatic discharge, press valve button all the way down, hooking the catch. Then place the fogger on the stand or table. Leave building at once and keep building closed for four hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.

To Kill Ticks and Fleas: Destroy pet's old bedding and replace with clean, fresh bedding after treatment is completed. Use product as above. Pets should be treated with a flea and tick control product registered for use on pets prior to reentering treated premises.

STORAGE: Store in a cool, dry place (preferably locked) inaccessible to children or pets and away from heat or open flame. **DISPOSAL:** Replace cap and discard container in trash. Do not incinerate or puncture.

PRECAUTIONARY STATEMENTS

Hazards to Humans & Domestic Animals

CAUTION: Harmful if swallowed. Contains petroleum distillate. Avoid breathing vapors or spray mist. Avoid contact with skin or eyes. Avoid contamination of food or feedstuffs.

Do not use in commercial food processing, preparation, food storage or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Exposed food should be covered or removed. Remove pets and birds and cover fish aquariums before spraying.

Statement of Practical Treatment

If Swallowed: Call a physician or poison control center immediately. Do not induce vomiting due to aspiration hazards. Gastric lavage may be indicated in cases of ingestion. **If In Eyes:** Immediately flush with plenty of water. Get medical attention if irritation persists. **If On Skin or Clothing:** Immediately remove contaminated clothing and wash before reuse. Wash skin with soap and warm water. Get medical attention if irritation persists. **If Inhaled:** Remove person to fresh air. Apply artificial respiration if indicated. Contact a physician if warranted.

Physical or Chemical Hazards

Contents under pressure. Keep away from heat, sparks and open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.
