



DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

[Storage and Disposal]

Storage: Store in a cool, dry (preferably locked) storage area inaccessible to children and pets and away from heat or open flame. **Disposal:** Do not puncture or incinerate! **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency of 1-800-CLEANUP for disposal instructions.

This product kills ants, cockroaches, confused flour beetles, crickets, fleas, houseflies, mosquitoes, rice weevils, sawtoothed grain beetles, small flying moths, sowbugs, spiders and brown dog ticks.

Shake Well Before Use

DO NOT use more than one fogger per room. **DO NOT** use in small, enclosed spaces such as closets, cabinets or under counters or tables. **DO NOT** use in a room 5 ft. x 5 ft. or smaller; instead, allow fog to enter from other rooms. **Turn off ALL ignition sources such as pilot lights (shut off gas valves), other open flames or running electrical appliances that cycle off and on (i.e., refrigerators, thermostats, etc.).** Call your gas utility or management company if you need assistance with your pilot lights.

Cover exposed food, dishes and food-handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Close doors and windows. Point valve opening away from face when releasing. Use one unit for each 5,000 cubic feet of unobstructed area. Do not remain in the area during treatment and ventilate thoroughly before reentry.

To operate valve: Place several layers of newspaper or a pad on a stand or table in the center of the room. Point valve opening away from face. To lock valve in open position for automatic discharge, press valve button all the way down, hooking the catch. Then place fogger on stand or table with valve locked open. Leave building at once and keep building closed for 2 hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in 2 weeks or when necessary.

To kill fleas and brown dog ticks: Destroy pet's old bedding and replace with clean, fresh bedding after treatment is completed. Use product as above. Prior to pets' reentry into treated area, treat pets with a flea and tick control product registered for use on pets.
