For dormant spraying of fruit trees, (mite and aphid clean-up) 12 gallons to 100 gallons of water

For delayed dormant or pink spray, (for mites and aphids) 7½ gallons liquid lime-sulphur 3/4 pint Black Leaf 40 100 gallons of water

For psyllids of potatoes, 2½ gallons liquid lime-sulphur 100 gallons of water

For psyllids of tomatoes,

1 gallon liquid lime-sulphur 4 pounds wettable sulphur 80 gallons of water

NOTE: Do not apply lime-sulphur when trees are in bloom, and do not apply after bloom within two weeks of any oil spray. Do not apply during periods of himb temperature, since sulphur sprays no burn foliage under such conditions. Use with care near buildings since discoloration of painted surfaces may result.

Directions for Dipping Cattle and Sheep Against Psoroptic and Sarcoptic Scab

In dipping cattle and sheep, use Tgalloh Sterling Liquid Lime-Sulphur to each 15 gallons of water.

Add Sterling Liquid Lime-Sulphur to offset loss from steam condensing through natural causes.

The repeat treatment time intervals should be 7 days and visibly affected animals should be held in the vat 2 to 3 minutes and their heads submerged at least once. Clean dipping vats thoroughly after each dipping.

- **CAUTION** Do not dip sick or debilitated animals.
 - Do not dip in cold or stormy weather. Do not dip animals having fresh wounds.

DIRECTIONS FOR USE

(a) Change the dipping vat solution as soon as it becomes excessively contaminated regardless of the number of animals dipped. (b) Do not use dipping solutions more than 10 days old.
