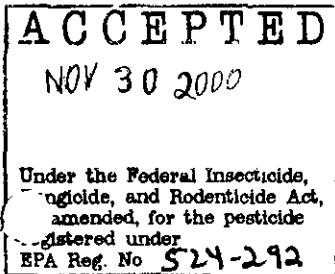


## SUPPLEMENTAL LABELING

**DIRECTIONS FOR USE**

It is a violation of Federal law to use Granular Far-Go® herbicide in any manner inconsistent with its labeling.

This label must be in the possession of the user at the time of herbicide application.

**RECOMMENDATIONS**

When used according to label directions, this product may be applied in the fall or spring to control wild oats in sugarbeets.

This product must be incorporated into the soil to a minimum depth of 2 inches. Follow all label directions for soil incorporation of this product.

**APPLICATION RATES AND TIMING**

Application is limited to one per growing season, either spring or fall, and must not exceed 15 pounds per acre.

**Use Rate**  
 15 pounds/acre

**When to Apply**  
 Fall application—Within three weeks of normal freeze-up or until snow cover occurs.  
 Spring application—Before seeding and before wild oats germinate.

**PERSONAL PROTECTIVE EQUIPMENT**

**Loaders, applicators\*, flaggers\*, and other handlers must wear:**

- Long-sleeved shirt and long pants
- Shoes plus socks

In addition, loaders must wear a NIOSH-approved dust mist filtering respirator with MSHA/NIOSH approval number prefix TC-21C or a NIOSH-approved respirator with any N, R, P, or HE filter.

\*See engineering controls for additional requirements.

**ENGINEERING CONTROLS\*\***

- Aerial applicators must be in an enclosed cockpit.
- Flaggers must be in an enclosed cab.
