





When there are not usual points of entry, signs must be posted in the corners of the treated areas and in any other location affording maximum visibility to sensitive areas. The printed side of the sign should face away from the treated area towards the sensitive area. Signs mus be posted prior to application and must remain posted until foliage has dried and soil surface water has disappeared. Posting signs may be obtained from your local farm chemical dealer.




