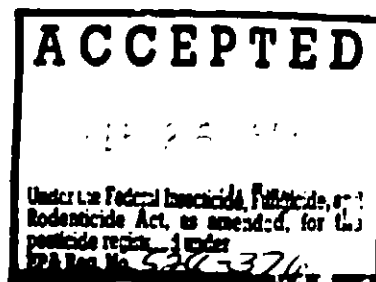

DIRECTIONS FOR USE.

It is a violation of Federal law to use this product in a manner inconsistent with the labeling.

This label must be in the possession of the user at the time of the herbicide application.

Landmaster II is a postemergence herbicide for control or suppression of emerged weeds in reduced tillage systems prior to planting or emergence of corn.



PERENNIAL WEEDS AND COVER CROPS IN CONSERVATION AND MINIMUM TILLAGE SYSTEMS.

Landmaster II at a use rate of 108 ounces per acre or Landmaster II at 54 ounces per acre plus the addition of 16 ounces per acre of Roundup and/or the addition of 0.42 pounds active ingredient per acre of 2,4-D will aid in the suppression of the following perennial weeds: hemp dogbane, orchardgrass, timothy, quackgrass, alfalfa and brambles. When applied as directed, the 54 ounces per acre rate of Landmaster II will provide postemergence control or suppression of rye, wheat and barley which are a maximum of 12 inches in height at the time of herbicide application. A nonionic surfactant which is labeled for use with herbicides may also be added at a 0.5 percent surfactant concentration.

Read the "LIMIT OF WARRANTY AND LIABILITY" in the label booklet for Landmaster II before using this product. Those terms apply to this supplemental labeling and, if those terms are not acceptable, return the product unopened at once.

Read and follow label directions for use of Roundup herbicide and 2,4-D herbicide.
