
DIRECTIONS FOR USE

Ranger is a postemergence herbicide used in agricultural systems for control of quackgrass and other weeds listed on the label booklet for Ranger.



When applied as directed under the conditions described, this product controls the weeds listed on the Ranger label booklet, prior to the emergence of the following crops:

Alfalfa
Barley
Beans (All)
Corn (All)
Forage Grass
Forage Legumes
Oats
Soybeans
Wheat

Do not plant subsequent crops other than those on the label for 30 days following application.

For control of quackgrass and associated annual weeds, apply 3 pints per acre of this product when the plants have reached the 3 to 4-leaf stage and are at least 6 to 8 inches high.

For quackgrass control in sods which have been established for 3 years or longer, use 3 to 6 pints per acre. Till fields within 7 days after application when using less than 4 pints per acre.

To control quackgrass in no-till cropping systems, use 6 pints per acre of Ranger.
