APPLICATION EQUIPMENT

Do not apply this product through any type of irrigation system.

This product may be applied using either ground or aerial spray equipment. Use extreme care to avoid misting or drifting of herbicide solution onto foliage, green stems or fruit of desirable crops. trees, or plants during both growing and dormant periods, since even small quantities of spray can cause severe plant injury.

Ground Application: Apply recommended rates of this product in 5 to 30 gallons of water per acre as a broadcast spray.
