PRECAUTIONARY STATEMENTS

HAZARD TO HUMANS AND DOMESTIC ANIMALS

DANGER!

CORROSIVE. CAUSES EYE AND SKIN DAMAGE. IRRITATING TO NOSE AND THROAT. HARMFUL OR FATAL IF SWALLOWED. WILL BURN WITH THE EVOLUTION OF CHLORINE AND EQUALLY TOXIC GASES.

Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Avoid breathing dust or fumes. Wash thoroughly with soap and water after handling. Remove and wash contaminated clothing before reuse.

ENVIRONMENTAL HAZARD

This product is toxic to fish. Do not discharge into lakes, streams, ponds, or public waters unless in accordance with NPDES Permit. For guidance, contact the regional office of EPA.

PHYSICAL OR CHEMICAL HAZARD

STRONG OXIDIZING AGENT. WILL BURN WITH THE EVOLUTION OF CHLORINE AND EQUALLY TOXIC GASES. CONTACT WITH WATER SLOWLY LIBERATES IRRITATING AND HAZARDOUS CHLORINE-CONTAINING GASES. DECOMPOSES AT 460°F TO 480°F WITH LIBERATION OF HARMFUL GASES.

Mix only with water. Use clean dry utensils. Do not add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire or explosion. Contamination with moisture, organic matter, or other chemicals may start a chemical reaction with generation of heat, liberation of hazardous gases, and possible generation of fire and explosion.

IN CASE OF: FIRE, if possible isolate container in open air or well ventilated area. Flood with large volume of water.

IN CASE OF: CONTAMINATION OR DECOMPOSITION, do not reseal container.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

FOR CONTROL OF BACTERIA AND ALGAE IN POOLS, SPAS AND HOT TUBS

STARTUP: To start up a new pool, spa or hot tub, or one that has been refilled, clean all surfaces and the filter and balance the total alkalinity at 125-175 ppm. Treat the water for iron, copper and manganese if present and adjust the pH to 7.5-8.0. Then add an EPA registered source of Sodium Bromide to provide an initial concentration of 5-10 ppm bromide ion. Follow the directions and precautions on the label for the registered Sodium Bromide product. As a guide, using a Technical Grade of registered source of sodium bromide at 95% purity, it requires 0.5-1 ounce per 100 gallons for spas or hot tubs and 0.5 to 1.0 lbs. per 10,000 gallons for swimming pools to provide 5-10 ppm bromide ion. The sodium bromide remains as a stable reserve in the water until the addition of CRYSTAL PURE 90M SANITIZER, Three Inch Tablets which cause bromine to be released. Place the CRYSTAL PURE 90M SANITIZER, Three Inch Tablets in a suitable floater or feeder. Adjust the feeder according to the manufacturer's directions to obtain an active bromine level of 2-6 ppm using a bromine test kit (or 1-3 ppm available chlorine using a chlorine test kit).

MAINTENANCE: The best results are usually obtained if the bromine levels, pH and total alkalinity are maintained as prescribed in the Startup Instructions. Test bromine level frequently. If the bromine level is below the prescribed levels, adjust feeder to increase tablet dissolution rate to maintain 2-6 ppm available bromine (1-3 ppm available chlorine). If the bromine (or chlorine) levels are above the prescribed limits adjust the feeder to decrease the tablet dissolution rate to maintain 2-6 ppm available bromine (1-3 ppm available chlorine). Wait until the levels drop to the prescribed levels before using the pool, spa or hot tub. Add tablets to feeder as necessary.

SHOCK TREATMENT: Water soluble, non-filterable wastes can accumulate in the water of pools, spas or hot tubs and cause dull or cloudy water and stimulate algae growth. For Shock Treatment, use CRYSTAL PURE 60M Granules (EPA Reg. No. 524-404) to establish the required levels of 10-20 ppm active bromine (5-10 ppm active chlorine). Follow the recommended dosages in the Directions for Use on the label for that product.

STORAGE AND DISPOSAL

STORAGE: Keep container tightly closed. Store in a dry place. Do not allow water to get into container. Keep container off wet floors.

PESTICIDE DISPOSAL: Do not contaminate water, food, or feed by storage or disposal. Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional office for guidance. Clean equipment and/or dispose of equipment wash water in a manner to avoid contamination of water resources.

For Household Containers: Securely wrap original container in several layers of newspaper and discard in trash.

CONTAINER DISPOSAL:

For Plastic Pail: Completely empty pail by shaking and tapping sides and bottom to loosen clinging particles. Rinse empty container with water, and dispose of it in a sanitary landfill or by incineration if allowed by state and local authorities.

For Fibre Drums: Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Dispose of liner in a sanitary landfill or by incineration if allowed by State and local authorities. Rinse empty container with water and dispose of it in the same manner.

For Household Containers: Do not reuse container. Rinse thoroughly before discarding in trash.
