This product is recommended for woody brush, tree and vine control in all non-cropland sites, including forestry, roadsides, rights-of-way, industrial, residential, fencerows, railroads and aquatic sites. Woody vegetation may be controlled by injection of E-Z-JECT selective injection herbicide capsules.

This product moves throughout the tree from the point of injection to all roots and shoots. Symptoms appear gradually (normally within 2 to 4 weeks), beginning with wilting, yellowing and browning of the foliage. This 1s followed by deterioration of all roots and shoots

For aquatic sites, this product may be injected into stems of trees and brush standing in water or wetlands. Do not apply directly to water or inject into stems below the water level.

Application Instructions

Inject the capsules using only the E-Z-JECT capsule injection equipment. The capsules must penetrate through the outer bark into living phloem tissue to provide effective results.

For trees with less than 2.5 inch DBH (diameter at breast height), inject one capsule per stem.

Inject one capsule every 4 inches, evenly around the trunk of the tree, below all major branches.

Tree may be injected at any time of the year except when wood is frozen.
