 Apply 1 qt per 5000 sq. ft. on the following established turfgrass lawns: Bahia, Bentgrass, Bluegrass, Bermudagrass, Centipede, Fescue, Ryegrass, St. Augustine, and dichondra lawns for control of crabgrass.

USE PRECAUTIONS: Do not reseed turfgrass lawns within four months after application. This product can be applied to dichondra lawns at the time of seeding or any time increafter. Keep children and pets off treated lawns until grass is completely dry.

when To USE: Application of this product must precede emergence of weeds from the soil. Crabgrass will emerge from the soil 4 to 6 weeks before it is visible above the turfgrass. If crabgrass is visible above the soil. it is too late to apply Greensweep® Preemergent Crabgrass Preventer. Where germination of crabgrass extends into the late summer and early fall, a second application should be made 4 to 5 months after the initial application.

HOW TO APPLY:

- Make sure ON/OFF valve is in OFF position.
- Shake well before applying.
- Connect spray nozzle to hose.
- Turn on the water at the tap.
