To refill: Add 2 1/2 Tablespoons of Roundup Concentrate Weed & Grass Killer or 4 teaspoons of Roundup Super Concentrate Weed & Grass Killer to this empty 24 fl oz bottle. Then add 24 fl oz (3 cups) clean tap water and use according to the label directions.

[For use with the 64 oz bottle]

To refill: Add 7 Tablespoons (3 1/2 fl oz) of Roundup Concentrate Weed & Grass Killer or 3 Tablespoons (1 1/2 fl oz) of Roundup Super Concentrate Weed & Grass Killer to this empty 64 fl oz bottle. Then add 64 fl oz (1/2 gal) clean tap water and use according to the label directions.

Once in contact with soil, it has no weed killing activity and will not move in or on the soil to affect nearby vegetation.

HOW TO USE:

IMPORTANT: This product is an all-purpose weed and grass killer which can injure or kill all plants contacted. APPLY ONLY WHEN AIR IS CALM. AVOID SPRAY CONTACT ON DESIRABLE PLANTS. IF NECESSARY, SHIELD DESIRABLE PLANTS TO PREVENT CONTACT WITH SPRAY. If spray or drift accidentally contacts desirable vegetation, wash off immediately with water. Rainfall within 6 hours could affect performance. Avoid mowing, cutting or otherwise disturbing sprayed vegetation for at least 7 days. For spot application adjust the nozzle to a coarse spray. Position sprayer tip approximately 1-2 feet from weeds, grasses, and undesirable plants, and apply until completely covered. Sprayed plants usually show effects within 3 days with complete kill in 2 to 4 weeks. For best results, apply to actively growing weeds, grasses and undesirable plants in warm sunny weather.
