DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Roundup® Grass & Weed Killer herbicide is a nonselective grass and weed killer which, when absorbed by contacted foliage, is carried throughout the stems and roots to give complete kill of tough labeled annual and perennial grasses and broadleaf weeds. This product has no herbicidal activity in the soil and will not wash or leach to affect nearby vegetation. It is formulated for "spot" application to kill individual weeds around trees, shrubs, fences, patios, walks and in flower gardens and lawns. Yellowing and wilting usually occur within one week with a complete kill in 2 to 4 weeks. For best results, apply to actively growing plants in warm sunny weather.

HOW TO USE: Adjust the nozzle to a coarse spray. Position sprayer tip approximately 12 feet from the weed and apply to completely cover the weed, stopping just before the spray begins to drip or run off. One application will control most listed weeds. If certain hard-to-control weeds are not completely killed within 4 weeks, repeat application. Treated areas in lawns can be reseeded 7 or more days after application.

WEEDS CONTROLLED: Bahiagrass, Barnyardgrass, Bermudagrass, Blackberries, Canada Thistle, Chickweed, Common Ragweed, Crabgrasses, Dandelion, Fescues, Field Bindweed, Field Sandbur, Foxtail, Johnsongrass, Kentucky Bluegrass, Lambsquarter, Orchardgrass, Perennial Ryegrass, Poison Ivy, Poison Oak, Quackgrass, Red Clover, Shepherdspurse, Smooth Bromegrass, Sowthistle, White Clover and Yellow Nutsedge.

IMPORTANT: This product is a nonselective weed killer which can injure or kill all vegetation contacted. **AVOID SPRAY CONTACT ON DESIRABLE PLANTS. APPLY ONLY WHEN THE AIR IS CALM.** If spray or drift accidentally contacts desirable vegetation, wash off immediately with water. Do not apply when rainfall is expected within 24 hours. Avoid mowing, cutting or otherwise disturbing treated vegetation for at least 7 days.
