PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

Keep out of reach of children.

CAUTION!

CAUSES EYE IRRITATION. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling.

FIRST AID

IF IN EYES

ENVIRONMENTAL HAZARDS

This pesticide is highly toxic to non-target plants.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in any manner inconsistent with its labeling.

This product may only be reformulated or repackaged into a herbicide for the following uses: winter and spring wheat, forestry conifer release, and non-crop areas.

STORAGE AND DISPOSAL

Do not contaminate water, foodstuffs, feed or seed by storage or disposal.

STORAGE: Store under cool, dry conditions (below 120°F). Do not store under moist conditions.

DISPOSAL: Wastes resulting from the use of this product that cannot be used or chemically reprocessed should be disposed of in a landfill approved for pesticide disposal or in accordance with applicable Federal, state or local procedures.
