- 3) Upon request, Monsanto must provide a report on the acreage where MON 87751 has been grown by States and territory.

Seed containing this pesticide product may only be planted for the purposes of agronomic evaluation, seed increase and production in breeding nurseries as specified in the terms and conditions of this registration and on the labeling. Commercial plantings of this product for the purposes of grain production and controlling insect pests are prohibited.

MON 87751 soybean may be combined through conventional breeding with other registered plant incorporated protectants that are similarly approved for use in combination, through conventional breeding, with other registered plant-incorporated protectants to produce soybean varieties with combined pesticidal traits.

Soybean has been transformed to express *Bacillus thuringiensis* Cry1A.105 and Cry2Ab2 proteins for the control of the following lepidopteran soybean pests:
