DIRECTIONS FOR USE

It is a violation of Federal law to use this product in any manner inconsistent with its labeling. Use only for the manufacturing or formulating of an herbicide for the following uses: 1) asparagus, barley, conservation reserve program (CRP), corn, cotton, fallow croplands (Between Crop Applications), general farmstead (noncropland), grasses grown for seed, hay, proso millet, pasture, rangeland, small grains, sod farms and farmstead turf, soybean and sugarcane; 2) uses for which U.S. EPA has accepted the required data or citations of data that the formulator has submitted in support of registration; and 3) uses for experimental purposes that are in compliance with U.S. EPA requirements. Consult Monsanto Company before using this product for formulating purposes. Each formulator is responsible for obtaining EPA registration for their end-use product(s). STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store in original container in a well-ventilated area separately from fertilizer, feed and foodstuffs. Avoid cross-contamination with other pesticides. Spillage or leakage should be contained, carefully swept up, and collected for disposal. Wash area of spill with detergent.

Pesticide Disposal: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate violates federal law. Triple rinse or pressure rinse container (or equivalent) promptly after emptying; then offer for recycling, if available, or reconditioning, if appropriate, or puncture and dispose of in a sanitary landfill, or by incineration, or by other procedures approved by state and local authorities. **Triple rinse containers as follows:** Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other

end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank, or store rinsate for later use or disposal. Repeat this procedure two more times. Dispose of rinsate in compliance with state and local regulations for pesticide products. Pressure rinse as follows: Empty the remaining contents into application equipment or mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank, or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. Drum Liner: Nonrefillable Container. Do not reuse or refill this container. Completely empty removable liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment; then dispose of empty liner in a sanitary landfill or by incineration, or by other procedures approved by state and local authorities. Drum: Refillable Container. Refill this container with pesticide only. Do not reuse this container for any other purpose. If drum is contaminated and cannot be reused, triple rinse the container before final disposal. Triple rinsing is the responsibility of the person disposing of the container. Fill the container about 10% full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this rinsing procedure two more times. Dispose of rinsate in compliance with state and local regulations for pesticide products. When this container is empty, replace the cap and seal all openings that have been opened during use; return the container to the point of purchase or to a designated location. This container must only be refilled with a pesticide product. Do not reuse the container for any other purpose. Prior to refilling, inspect carefully for damage such as cracks, punctures,

Abrasions, worn-out threads and closure devices. Check for leaks after refilling and before transport. Do not transport if this container is damaged or leaking. If the container is damaged, or leaking, or obsolete and not returned to the point of purchase or to a designated location, triple rinse emptied container and offer for recycling, if available, or dispose of container in compliance with state and local regulations. (Supersack) Nonrefillable Container: Do not reuse or refill this container. Completely empty bag into application equipment; then dispose of empty bag in a sanitary landfill or by incineration, or by other procedures approved by state and local authorities.
