DIRECTIONS

Apply by dipping, brush or spraying. BARCOSOTE can be applied to all unpainted wood that is not to be painted (fence posts, foundation timbers and heavy wood members) by dipping, brushing or spraying. One gallon will cover an area of approximately 100 square feet. Wood should be thoroughly dried before application of BARCOSOTE for best penetration. For cold weather application, heat BARCOSOTE to 125° F. For wood which is to be in contact with the soil, a thorough dip application is recommended. However, where impractical apply two thorough coats by the brush or spray method. For maximum penetration, allow wood to soak for a minimum of 12 hours, when treated by the dip method. Fence posts should be debarked, dry and well seasoned before treating with BARCOSOTE. Wear protective clothing and rubber gloves when handling the freshly treated lumber.

USE BARCOSOTE FOR

Preserving fence posts, rails, timbers, gates and planking. Protecting exposed wood against rot and decay. Prevents fungi and molds of wood. Controls termites and powder post beetles. Treatment of wood shingles and preserving ground line areas of telephone and power poles. For protection against termites treat wood prior to use in construction.

WARNING

Avoid contact with skin and clothing as it may cause skin irritation. Before handling BARCOSOTE or freshly treated wood, hands should be coated with Linseed Oil or grease to protect the skin. Remove clothing that has become soaked with BARCOSOTE. Do not use inside dairy barns, silos, poultry houses or other structures where it may contact food, feed or livestock. This product is toxic to fish and wildlife. Keep out of lakes, streams or ponds. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label. May be fatal or harmful if swallowed. May cause severe burns. Avoid inhalation of spray mist.
