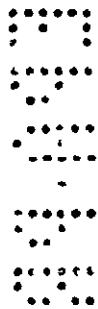

GENERAL CLASSIFICATION

CATTLE (For Self-feeding):

Allow free choice to cattle. Cattle should consume an average of 3/4 lb. of this product per 100 pounds of body weight per month. This will supply the recommended average daily intake of 70 mg. of RABON per hundred pounds body weight. Animals should not be starved for minerals before initiation of this Mineral Mix product but OMIT all salt from other feed after the program is started. Do not feed other free choice sources of salt or mineral containing salt in any form. Do not feed RABON in other feeds when using this self-feeding (free-choice) method. Allow one mineral feeder for each 15-20 head, and place near watering and loafing areas. Put out no more than one month's supply at a time, and protect from rain.

If consumption of FS 2:1 MINERAL with RABON is above 3/4 lb. per 100 lbs. of body weight per month, reduce the number of feeding locations or relocate. If consumption is below 3/4 lb. per 100 lbs. of body weight per month, increase the number of feeding locations.

This mineral mix containing RABON may be fed up to slaughter and to lactating dairy cows. Start feeding this product early in the spring before flies begin to appear and continue feeding throughout the summer into the fall until cold weather restricts fly activity.
