

DIRECTIONS

GENERAL Apply with a manufacture sprayer that can deliver a pin stream of insecticide.

Spray surfaces only until wet. Avoid excessive runoff. Apply to all insect breeding sites and harborages. Also treat adjacent exposed surfaces where insects may crawi when they come out of hiding. Repeat treatment as necessary. SILVERFISH, FIREBRATS Apply to localized areas infested by these insects.

BROWN DOG TICKS---Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and local areas of floors. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals.

CLOVER MITES, CRICKETS, EARWIGS, MILLIPEDES, CENTIPEDES, SOWBUGS. AND SPIDERS-Thoroughly spray the interior and exterior perimeter of infested premises. For CLOVER MITES, give attention around window frames.

CADELLES, CIGARETTE BEETLES, DRUGSTORE BEETLES, INDIAN MEAL MOTHS. MEDITERRANEAN FLOUR MOTHS, RED FLOUR BEETLES, SAW-TOOTHED GRAIN (Exposed stages)-Thoroughly treat floors and the walls BEETLES of the infested area with attention to cracks, crevices, corners and perimeters.
