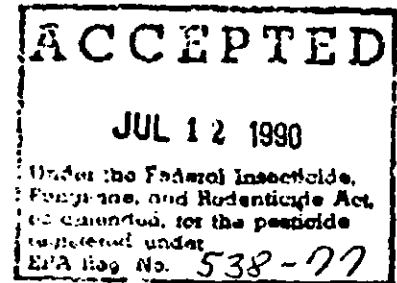

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

DO apply in spring (between second and fifth mowing) at regular rate to prevent crabgrass and to control actively growing weeds (listed above). Apply at Scotts Spreader (Standard, Automatic or Precision Flow Control Model) setting . . . . . 6 3/4 (Treats 5,000 sq ft) In Colorado apply at setting 7 (treats 4,500 sq ft)

DO apply in fall (September-October) or in the spring (between the second and fifth mowing) at heavy rate to prevent barnyardgrass and foxtail in addition to crabgrass. The heavy rate application also controls actively growing weeds (listed above).

Apply at Scotts Spreader (Standard, Automatic or Precision Flow Control Model) setting . . . . . 7 1/2 (Treats 4,000 sq ft)

BACK CONTINUED:

- DO slightly overlap spreader wheel tracks for complete coverage.
- DO apply only when lawn is wet from dew, rain or thorough watering (very important so that the particles will stick to the weed leaves instead of falling to the soil).
- DO withhold watering lawn for at least 24 hours after application (to avoid washing particles off the weed leaves).
- DO apply on a calm day.
  
- DON'T use on lawn of creeping bentgrass, carpetgrass, St. Augustinegrass, dichondra or improved varieties of bermudagrass.
- DON'T apply on newly seeded or sodded areas until the grass has received its fourth mowing.
- DON'T seed or sod for 4 growing months after application.
- DON'T apply to shrubs, flowers, fruit or vegetable plants.
- DON'T make application at less than four month intervals.
- DON'T rake or aerify after application to avoid disturbing the crabgrass prevention barrier in the soil.
- DON'T use this product to control crabgrass or other wild grasses already up and growing Scotts recommends SUMMER CRABGRASS CONTROL to control actively growing crabgrass.
- DON T expect control of dandelions overnight. A month of good growing weather may be required for complete control.
