

Directions for use

Directions for use

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes.

Keep children and pets off treated areas until material has been washed off the foliage and the area is completely dry. Do not feed clip,plngs from treated turf to livestock and poulty. Do not contaminate feed or foodstuffs.

Prevents or arrests the turfgrass diseases brown patch, dollar spot, and copper spot. In Washington, Oregon and California only, prevents or arrests snow mold (Fusarium patch).

Not a control for leaf spot or gray snow mold on turf.

Not a season long (all winter) control of snow mold unless applied on a 2 to 3 week application program.

Turf

For prevention of dollar spot, copper spot, and brown patch, apply to moist or dry foliage at the NORMAL RATE when disease activity is noted or suspected and repeat at 2 to 3 week intervals. Brown patch control may require more frequent treatments under conditions especially favorable to disease activity.

To avoid product pickup, lightly irrigate treated areas soon after application. 'If dollar spot control is not effective following the use of this product as recommended, a thiophanatemethyl or benomyl tolerant strain of fungi may be present. Consult your ProTurf Tech Rep., as consideration should be given to prompt use of other sultable ProTurf fungicides.

For prevention of snow mold, apply at the NORMAL RATE to dry foliage when disease activity is anticipated. Repeat at 2 to 3 week intervals.

For suppression of snow mold in areas where snow cover occurs, apply to dry follage at the DOUBLE RATE prior to the first snow. Repeat in mid-winter when turf is free of snow and again immediately after the final snow melts in the spring.

Allow one week between application of this product and other turf control products except where severe insect or disease attack requires immediate treatment.

STORAGE AND DISPOSAL
