Apply either to moist or dry foliage any time Poa annua is actively growing from late spring through early fall. For best control temperatures should be consistently in the 70's or higher and soil moisture should be adequate for active growth. Normally 3-4 weeks are required for control under these conditions. In cooler weather a repeat application in 8-10 weeks may be required for satisfactory control.

On organic soils, such as muck or peat, apply at the NORMAL RATE. On mineral soils apply at LIGHT RATE.

CAUTION - Poa annua content in bluegrass is often greater than it appears. Its removal may produce a thin overall turf. Time and adequate maintenance will be required to regrow a dense turf. In certain areas this product may cause temporary discoloration of bluegrass sod.

PRECAUTIONS

Treated sod should not be cut sooner than ten weeks after treatment. (Normally bluegrass sod is not cut after mid-November.)

Do not use on bentgrass and fescues or fescue mixtures. Avoid application when frost or freezing weather is expected. In general applications should not be made after mid-September.

On newly seeded bluegrass application should be withheld until after the third mowing. Treated areas should not be seeded for at least three months.

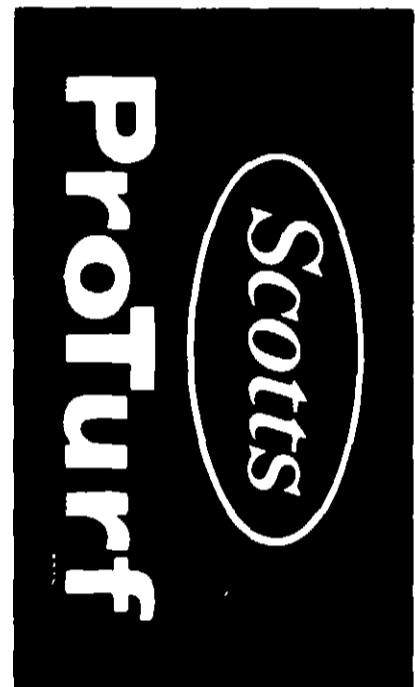
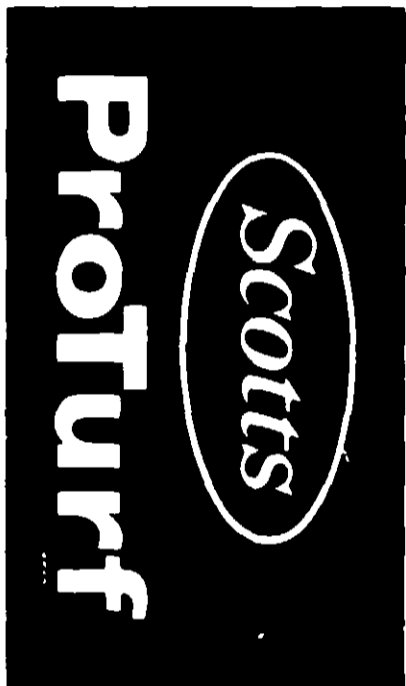

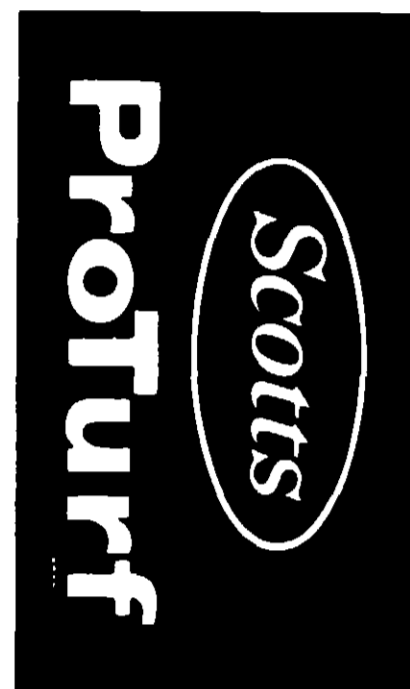
