Dear Registrant:

The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, successfully REMOVES THE PRODUCT FROM THE SCOPE of PR Notice 93-7 one the comments (if any) on the attached sheet are addressed. Other than the alterations (if any) listed on the attached sheet, no further alterations to the labeling are necessary to reflect the requirements of the Worker Protection Standard.

Since your amendment proposes to delete uses directly and/or to delete uses implicitly through the use of exclusionary statements), the Agency will publish in the Federal Register a notice of receipt of your amendment to delete uses, as required by section 6(f)(1) of FIFRA. The Agency will defer action for 90 days from the date of the Federal Register notice to give affected minor users an opportunity to try to persuade you to retain the uses(s). When the comment period has expired, the Agency will approve the amendment unless you have withdrawn it, and stamp the amended labeling "accepted." Your stamped-accepted labeling will then be sent to you.

As described in Supplement A of PR Notice 93-11 (self-verification option), you may sell and distribute product bearing the submitted labeling before you receive a copy of your stamped-accepted labeling. Note that your registration is not amended until the comment period required by section 6(f)(1) of FIFRA has expired and the Agency has approved the amendment. Therefore, you may withdraw your proposed amendment at any time during the comment period and until you receive your stamped-accepted labeling.

Directions for use

It is a violatior of federal law to use this product in a manner inconsistent with its labeling.

Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for reasearch purposes.

Apply anytime weeds are actively growing. Do not apply when ground is frozen.

For bentgrass putting greens

For bentgrass putting greens, apply at the QUARTER RATE to moist foliage for control of clover and chickweed. Repeat treatment in 3 weeks if needed. (Treats $44,000~\rm{ft}^2$).

For use on other turfgrass areas

For turfgrass areas other than greens, apply to moist foliage at --

HALF RATE to control clover (treats 22,000 ft²)

NORMAL RATE to control knotweed, chickweed (common and mouseear), sheep sorrel and black medic (treats $1,000 \text{ ft}^2$).

DOUBLE RATE to control wild onion, curly dock, ground ivy, Canada thistle, cudweed, yarrow and horseweed. For control of yarrow, wild onion and garlic, start treatments in either Spring or Fall and repeat at 6 month intervals for a total of 2 or 3 applications as needed (treats 5,500 ft²).

BACK CONTINUED:

NOTE:

Avoid application on rootzone areas of trees and shrubs.

Do not apply when ground is frozen.

Delay planting grass seed until after a heavy rain or watering and not sooner than two weeks after treatment.

On new plantings, delay treatment until after the second mowing.

Not for use on St. Augustinegrass or dichondra.

Avoid application to garden plants, flowers, and rootzone areas.

Storage and disposal

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in a clean, dry place. Reseal opened bag by folding top down and securing.

PESTICIDE DISPOSAL: Do not contaminate water, food, or feed by storage or disposal. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
