Statement of Practical Treatment:

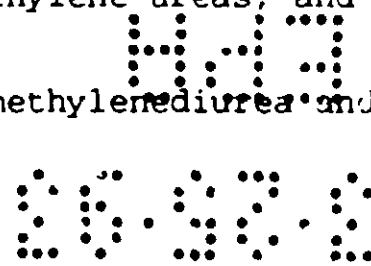

Directions for Use

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

- When to use: (control of active insects)

Apply at the first sign of insect activity.

Chinch bug activity is evidenced by yellowing and then browning of the grass. This often develops in localized areas, occasionally spreading through the entire lawn. On treated areas adjacent to heavily chinch-bug-infested areas, check for reinfestation at about 4 to 8 weeks, depending on conditions. If renewed activity is observed, re-treat immediately.

Moths flying over the lawn is an indication of sod webworm, cutworm, and/or armyworm larval activity. Renewed activity of these insects may be encountered within 4 to 8 weeks in high incidence areas such as Kansas, Missouri, or Kentucky. In northern areas (such as the Dakotas, Minnesota, Wisconsin, etc.), one damaging generation is normally encountered.

□ How to use:

For chinch bugs, sod webworms, cutworms, and armyworms, apply at the NORMAL RATE.

For sod webworms, cutworms, and armyworms, water lightly after application to remove granules from the grass blades. For chinch bugs, water thoroughly (1/4 to 1/2 inch of water) after application.

Do not mow or collect clippings for 24 hours after treatment.

Allow one week between the application of this and other control products, except where a severe insect or disease attack requires immediate treatment. Allow at least 4 weeks between fertilizer applications. If an interim treatment is needed, use a control product without fertilizer.

□ Results to expect:

Control of damaging insects listed above, plus fertilization to aid in recovery of the turf. Control of insects may require a week, but will take no more than 2 weeks. If severe damage is noted before the first application, recovery of the turf may be slow or seeding may be required to fill in damaged areas.

- Operate spreader the longest direction of the lawn.
- Overlap wheel tracks to ensure uniform feeding.
- Shut off spreader when you have reached the header strips or stopped.

EasyGreen® Rotary:

- Slide shutoff lever to the right. Application automatically starts and stops when you do.
- Avoid misses by making each pass about 30 inches from the previous one, so some overlapping occurs.

SpeedyGreen® Rotary:

- Shut off spreader anytime you stop.
- Avoid misses by making each pass about 5 feet from the previous one, so some overlapping occurs.
