A new labor saver for your St. Augusine lawn! When applied during the growing season, this product stops the growth of St. Augustinegrass for 6 weeks. So you have a well groomed lawn that requires no mowing. You simply apply this product to your lawn with a spreader like you would any granular fertilizer. Then put your lawn mower away for 6 weeks.

Apply to St. Augustinegrass when it is green and actively growing. If grass is tall enough to touch the bottom of the spreader, mow at least 1 day before application. Remove excessive grass clippings and leaves before making treatment.

Apply to grass foliage that is wet from dew, rain, or thorough watering. After application, withhold watering for 24 hours, and don't apply if rain is expected within 24 hours.

Apply product at the spreader settings listed below. Follow straight lines and overlap wheel tracks to avoid stripes of untreated lawn. Do not use a rotary (broadcast) spreader.

- Ortho 6
- Sears 8
- Scott 43/4

Mow the lawn about 1 week after treatment. This is the only mowing required for uniform height for 6 weeks.
