You may have some questions about this product, since it is quite different from regular fertilizers. Here are answers to some commonly asked questions:

1. How will this product help me grow grass in the shade?

Plants growing in the shade naturally try to stretch for more light. With grass, this stretched growth is removed by the lawn mower, causing shady lawns to be thinner than a lawn growing in the sun. The Shade Growth Enhancer in Scotts Growth Manager for St. Augustinegrass, however, encourages grass plants to spread, making the lawn thicker and allowing the grass to capture more sunlight.

2. What if I have very little grass growing in my shady lawn areas?

If the shady area receives some sunlight for 3 or more hours per day, plant a special seed mixture such as Scotts Shady Area or Perfect Choice for Shady Areas and apply Starter Fertilizer the same day. After the new grass has been mowed three times, apply Scotts Growth Manager for St. Augustinegrass at the recommended rate.


If the area receives less than 3 hours of sun each day, you will need to prune the trees to allow more sun to shine on the area. If that is not possible, you can plant a ground cover such as creeping vinca or pachysandra, or spread bark mulch over the area.

3. What if there is moss growing in the shady area of my lawn?

Apply Turf Builder Plus Moss Control to eliminate the moss, followed by an application of Growth Manager for St. Augustinegrass 6 to 8 weeks later. If there is very little grass growing in the area after the moss dies, follow the recommendations in the answer to question #2.

4. What if part of my lawn is in shade and part in full sun?

It's okay to use Growth Manager for St. Augustinegrass on the entire lawn, but for best results in full sun, use regular Turf Builder fertilizer.


Directions for use

- o On cool season grasses such as Kentucky bluegrass, fine fescue, perennial ryegrass, apply at the NORMAL RATE.
- On tall fescue, centipede, and St. Augustinegrass, use the HEAVY RATE. Apply to centipedegrass only in the spring; up to two applications may be made.
- o This product may be applied at 8-week intervals.
- o Apply when grass is wet or dry. For best results, water if rainfall does not occur within 2 days. Continue to provide adequate water during periods of extended dry weather.

PRECAUTIONS:

- o If a weed, disease, or insect problem occurs, apply a recommended control product in the normal manner. This product is compatible with other lawn products.
- o Not for use during periods of extreme dry or cold weather or during heavy insect or disease activity.




