APPLICATION

- . Apply anytime weeds are actively growing. On bahia and centipede lawns wait until after the second mowing of the year but not before mid-March. In the fall, do not treat centipede after the first of October and do not treat bahia after the first of November. Make sure grass does not touch bottom of spreader.
- . Apply on a calm day.
- . Apply to moist grass. To help the particles stick to weed leaves, the grass should be thoroughly watered or wet from dew before applying Turf Builder with Plus 2(R) for Lawns.
- . Do not apply on the rootzone areas of shrubs or under the branch spread of trees.
- . Do not use this product on flowers, shrubs, fruit or vegetable plants or creeping bentgrass, St. Augustine, dichondra, lippia, carpetgrass lawns.

WATERING OR RAIN

Do not water your lawn for 24 hours after application. Water will wash the weed control off the weed's leaves and reduce the effectiveness of this product.

This product should not be applied if rain is expected within the next 24 hours.

SPREADER

Be careful when applying this product near shrubs, flower beds or vegetable gardens as contact with weed control may damage these desirable plants. Scotts PF Drop Spreaders provide excellent controlled application to protect these areas. When using the EasyGreen™ Rotary Spreader take special care near desirable plants.

IMPORTANT

WHAT TO EXPECT

Weed stems and leaves will begin to twist and curl in a few days, but a month or more may be required for complete control.

This product will not prevent weed seeds from producing new plants.

EXTREME TEMPERATURES

Don't apply when temperatures are expected to exceed 90°F degrees.

SEEDING/SODDING/SPRIGGING

After application, wait one month before planting. If you have already planted, wait until the new grass has been mowed at least four times before applying Turf Builder with plus 2^(R) for Lawns.

TIPS ON SPREADING WITH SCOTTS SPREADERS

PF Drop:

- First apply 2 header strips
- Operate spreader the longest way of the lawn
- Overlap wheels to insure uniform feeding
- Shut off spreader when you have reached the header strips or stopped
- Mow lawn first if grass is tall enough to touch the bottom of spreader

- Slide shut-off lever to the right. Application automatically starts and stops when you do
- Avoid misses by making each pass about 30 inches from the previous one so some overlapping occurs
