
Finally, the following certification is provided on behalf of The O. M. Scott and Sons Company as required in the Agency's letter of October 30, 1992.

APPENDIX
(PROFESSIONAL, GRANULAR)

The following changes have been made to the attached product label containing 2,4-D. The basis for these revisions were Professional (including sod), granular product.

In the Hazards to Humans and Domestic Animals section, we added the following:

"When mixing, loading or applying this product or repairing or cleaning equipment used with this product, wear eye protection (face shield or safety glasses), chemical resistant gloves, long-sleeved shirt, long pants, socks and shoes. For aerial applicators in enclosed cockpits and applicators applying this product from a tractor that has a completely enclosed cab, eye protection is not required."

"For early entry to treated areas that is permitted under the worker protection standard and that involves contact with anything that has been treated, such as plants, soil or water: wear eye protection (face shield or safty glasses, chemical resistant gloves, long-sleeve shirt, long pants, socks and shoes."

"Wash hands, face and arms with soap and water as soon as possible after mixing, loading, or applying this product. Wash hands and arms before using the toilet. After work, remove all clothing and shower using soap and water. Do not reuse clothing worn during the previous day's mixing and loading or application of this product without cleaning first. Clothing must be kept and washed separately from other household laundry. Remove saturated clothing as soon as possible and shower.

"Do not allow people (other than the applicator) or pets on treatment area during application. Do not enter treatment areas until spray has dried or dust has settled."

We have amended the Directions for Use to include the following statements:

AGRICULTURAL USE REQUIREMENTS

"Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application."

"Use this product only in accordance with its labeling and with the Workers Protection Standard, 40CFR part 170. This standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label (in this labeling) about personal protective equipment and restricted-entry interval."

For use on ornamental Turfgrass areas other than putting greens.

Apply to moist foliage at the RECOMMENDED RATE or for better distribution when using a rotary spreader, apply at the HALF RATE with a reduced width of coverage (see spreader settings). Apply when weeds are growing actively. Grass should not be so tall it touches the bottom of the spreader.

Rain, sprinkling, mowing, or heavy traffic within 24 hours after application can knock granules off weeds and may reduce effectiveness. Apply under non-windy conditions, thereby reducing drift to non-target areas, and optimizing particle distribution for good weed control. Retreating may be necessary, but wait at least 3 weeks to observe full results of first application.

Precautions

Avoid application when daytime temperatures are consistently 90°F or above.

Do not over apply, especially under the branch spread of trees and shrubs.

On new grass plantings delay application until after the fourth mowing.

Delay planting grass seed until after a heavy rain or watering and not sooner than 1 month after application.

Not for use on creeping bentgrass, St. Augustinegrass, carpetgrass, dichondra, ground covers, garden plants, flowers and shrubs.

Do not apply to centipedegrass turf in the Spring before March 15 (or before the danger of frost has passed), or after September. Do not apply to bahiagrass before March 15 or after November 1.

Storage and disposal

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in a clean, dry place. Reseal opened bag by folding top down and securing.
