**STORAGE AND DISPOSAL**

**STORAGE:** Keep from freezing. Do not store above 95°F. To be stored in original container with child-resistant cap and placed in a locked area inaccessible to children. Do not store near feed or foodstuffs.

**PESTICIDE DISPOSAL:** Product remaining in original container should be disposed of by securely wrapping original container in several layers of newspaper and discarding in trash. - Do not water your lawn until 48 hours have passed since treatment. This product should not be applied if rain is expected within 48 hours.
- Regular lawn watering is necessary to maintain a quality lawn. During periods of drought or hot, dry weather (exceeding 85°F), do not use this product until the rains occur or the lawn is watered.

**PRECAUTIONS**

- Apply on a calm day to avoid spray drift to non-target plants.
- Wait until you mow three or four times before you use this product on new grass.
- Avoid applications near shrubs, flowers, fruit or vegetable plants as plant injury may occur.
- Delay planting grass seed, sodding or sprigging until after a heavy rain or watering and not sooner than three to four weeks after treatment.
- Not for use on creeping bentgrass, St. Augustinegrass, carpetgrass, dichondra, lippia or similar ground covers.

**DIRECTIONS FOR USE**

- Shake well before applying. ✓
- Connect spray nozzle to your garden hose. ✓
- Hold bottle by the neck, remove child-resistant cap, attach bottle to nozzle.
- Avoid squeezing the bottle as contents may spray through the nozzle opening.
- Adjust on/off switch to the "OFF" position, then turn on water at the faucet.
- Beginning at a point furthest from your faucet, turn the on/off switch to the "ON" position.
- Holding the bottle in front of you at waist height, use a moderate, side-to-side swinging motion to apply the product. Each pass should cover approximately an 8 to 10 foot swath.
- Walk at a steady pace and overlap treated areas by at least one foot to ensure proper coverage.
