FOR USE ON ESTABLISHED TURFGRASS,
DICHONDRA AND PUTTING GREENS

For most effective control of Poa annua (annual bluegrass), henbit, shepherds purse apply in late summer or early fall, before germination. Repeat yearly. (West of Cascades in Oregon and Washington apply annually in early spring and late summer).

To control spring-sprouting weeds apply in winter or before the second mowing in spring, before these weeds sprout.

Turf may be either moist or dry.

PRECAUTIONS

Do not use on areas composed of 50% or more Poa annua.

On newly planted areas, wait until grass has been mowed at least twice and has made good coverage. On newly planted dichondra no waiting is necessary.

After application, avoid any severe aerating or raking which might disturb the surface and break the chemical barrier.

Delay any new grass planting for 4 "growing" months.

Applications should not exceed twice yearly.
