GENERAL DIRECTIONS TREATMENT FOR TERMITES

STEP ONE: PREPARE THE BUILDING

Repair existing damage. Eliminate wood-to-ground contacts. Remove wood debris, trash and rubbish from around and beneath the building. Scrape away termite shelter tubes from foundation walls and piers. Tunnel into dirt-filled areas beneath porches and terraces. Drill access holes through mortar joints into voids in masonry foun lations, fireplaces and flues (8 inches apart, 6 inches above grade level).

STEP TWO: DIG THE TRENCH

Dig a narrow trench along the outside and inside of foundation walls to a depth of about 15-18 inches, but no deeper than the top of the footings. Trench around other danger areas such as piers, conduits and all pipes entering house from ground. If the building has deep foundations, trench to a depth of 30 inches.

STEP THREE: PREPARE THE MIXTURE

Dilute at the rate of 1 quart SEARS TERMITE KILLER AND CONTROL with 25 gallons of water or 1 gallon with 99 gallons of water. Keep the mixture stirred up. If allowed to stand, restir before using.

STEP FOUR: APPLY THE TREATMENT

Insic roundation walls: Apply 4 gallons to 10 lineal feet of trench along foundation walls and around piers and utility entrances. If trench is deeper than 15-18 inches or 30" deep for buildings with deep foundations, apply 8 gallons per 10 lineal feet. Replace soil and apply another 4 gallons per 10 feet. Apply 1 gallon to each 10 square feet of soil surface in crawl space.


Outside foundation walls: Apply 4 gallons per 10 lineal feet in a trench along the outside of foundation walls, including entrance platforms and porches. If trench is deeper than 15-18 inches but not over 30 inches deep, apply 8 gallons per 10 lineal feet. Replace soil and apply another 4 gallons per 10 feet.

Porches and terraces: Drench soil under porches and terraces at the rate of 1 gallon per 10 square feet.

Voids: Flood voids in concrete block, brick or tile foundations, fireplaces and flues with 4 gallons each 10 feet.

It also gives temporary protection to cereal crops, corn and soybeans against certain soil-borne diseases such as root rot, seedling blight and for temporary protection of seeds and seedlings against wireworms.

Directions For Use

WHEAT, BARLEY, OATS, RYE—Use rate of 2 oz. per bushel.

FLAX—Use rate of 4 oz. per bushel.

CORN AND SOYBEANS---Use rate of 2% oz. per bushel.

MIX AGSCO DB-GREEN-A THOROUGH-LY into the seed until uniformly applied by:

- (1) Use an AGSCO Automatic Seed Treater that meters in the proper amount of AGSCO DB-GREEN-A and uniformly mixes it as clean untreated seed is augered from the grain box into the planter or drill box as uniformly treated seed.
