DIRECTIONS

RUBBER AND ASPHALT TILE FLOORS: Spray dust mop lightly with PURI-MIST and ALLOW MOP TO DRY FOR 8 HOURS BEFORE USING. Apply dust mop to floor in the usual manner. Repeat application as often as necessary. Do not spray PURI-MIST directly on rubber or apshalt tile floors.

FINISHED WOOD FLOORS: To Clean—Spray PURI-MIST lightly over the floor. Allow to stand for a few minutes, then remove excess with a soft mop or cloth.

To Maintain—Spray PURI-MIST lightly on a soft mop and go over the floors in the usual manner. Mop should be only moistened, not saturated.

UNFINISHED WOOD FLOORS: Spray a sufficient quantity of PURI-MIST on the floor to penetrate into the pores and loosen the imbedded dirt. Allow to stand a few minutes, then sweep with a stiff brush or broom.

NOTE: It is important to have a clean mop in order to get best results and maintain attractive floors. Wash dust mops in a mild neutral soap solution. Wring out thoroughly and allow to dry.
