

DIRECTIONS FOR USE

FOR SPOT APPLICATION ONLY

Do not use in edible products areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

German roaches, American roaches, Oriental roaches: Effective spraying necessitates the treatment of the hiding places of the insects with special care being careful to treat all cracks and crevices in the woodwork, dark places behind pipes, and all other probable hiding places.

Repeat applications in order to maintain an effective deposit of the residual toxicant.

There will be no scattering of the infestation.

Silverfish and firebrats will be controlled by this same application. Be careful to treat baseboards, areas behind shelving, bookcases and storage areas.

Ants: This spray is equally effective for the control of both "grease or fat" eating ants and "sweet eating" ants. Thoroughly spray runways and other places which they frequent. Do not use near food. Residual effect will remain 3 to 4 weeks. Since this spray does not scatter the ants, entire colonies can be destroyed. Repeat applications in order to maintain an effective deposit of the residual toxicant.

Remove pets, birds, and fish bowls before spraying. Do not contaminate fish ponds. This product is toxic to fish and wildlife.

Do not reuse empty container. Destroy it by perforating or crushing. Bury or discard it in a safe place.
