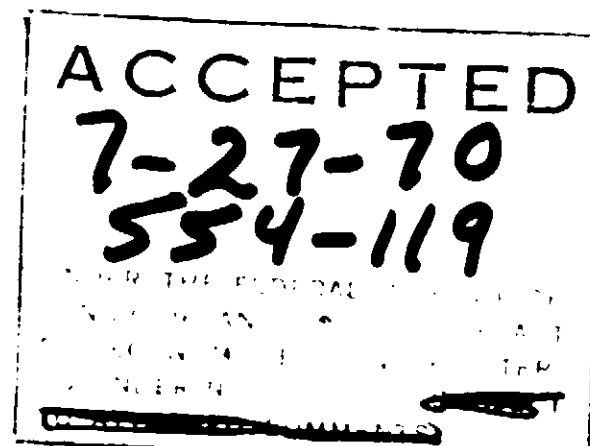


WARNING

DIRECTIONS FOR USE

POTATOES: Use 2 quarts per acre for control of Colorado potato beetle, leaf-hoppers and flea beetles. Repeat at 7-10 day intervals as needed for control.

FORAGE CROPS (Alfalfa, Clovers and Grass): Use 2-3 quarts per acre for control of Alfalfa Caterpillars, Alfalfa Weevil (larvae), flea beetle, leafhoppers, Lygus bugs, spittle bugs, armyworm, fall armyworm.

Repeat at 7-10 day intervals as needed for control!

Do not apply later than 7 days before harvest or grazing.

GROUND APPLICATION: Apply at the rate of 5-10 gallons of diluted pesticide per acre.

AIRCRAFT APPLICATION: Apply at the rate of 3-5 gallons of diluted pesticide per acre.
