WHEAT — OATS — BARLEY — RYE

For Armyworm control — Use when larve are young.

For Grasshopper control — Use when grasshoppers are young.

Do not feed treated forage to dairy animals or animals being finished for slaughter. No restriction on the use of the grain.

GROUND APPLICATION: Apply at the rate of 1½-2 lbs. actual/acre (1 quart to 2¾ pints) in 5 to 10 gallons of water for adequate coverage.

AERIAL APPLICATION: Apply at the rate of 1½-2 lbs. actual/acre (1 quart to 2¾ pints) in 3 to 5 gallons of water for adequate coverage.
