4. Submit five copies of the final printed label for the record.

5. It is noted that your submission dated March 4, 1993, included Product Chemistry data and Acute Toxicity data for DB-Green L. Upon review of the above data, it is understood that the Agency may require changes to your registration/labeling.

6. On your Confidential Statement of Formula (CSF), correct the upper and lower certified limits, in column 14 a and b, for the active ingredient Maneb 80. According to 40 CFR part 158.175, using a nominal concentration of 25.6 %, the upper limit should be 26.37 and the lower limit should be 24.83. Submit a corrected CSF.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec.6(e). Your release for shipment of the product constitutes acceptance of these conditions.

AGSCO DB-GREEN L is a special seed treatment formulation of maneb and lindane, which when used at the correct dosage rates, protects crops against seed-borne disease such as stinking smut (bunt) of wheat, oat smuts, covered and false loose smuts of barley and bunt of rye. It also protects cereal crops against certain seed and soil-borne diseases such as seedling blight (phase of root rot) caused from black-pointed seed or scabby seed and for temporary protection of seeds and seedlings against wireworms. DB-GREEN L is especially designed for on-the-farm treatment using a seed treater suitable for metering and mixing flowable seed treatment.

Use AGSCO DB-GREEN L at the following rate:

WHEAT, OATS, BARLEY and RYE: 3 fl. oz. per bushel. **CORN, SOYBEANS and SUNFLOWERS:** 4 fl. oz. per bushel. Use only the recommended rate. Lower amounts may not give the desired control. Higher amounts may cause seed injury. Uneven treating of seed may cause over-treatment on some seed kernels and under-treatment on other seed kernels. Seed should be well cured, dry and cleaned before treatment. For maximum benefits, avoid deepseeding and exceptionally early sowing under poor growing conditions.

USE RESTRICTIONS

Treat only those seeds needed for immediate use, minimizing the interval between treatment and planting. Do not store excess treated seeds beyond planting time. Treated seed must not be used for or mixed with food or animal feed, or processed for oil. If this product is used on a crop, no other product containing a different EBDC active ingredient may be used on the same crop during the same growing season.

DISCLAIMER FOR SEED TREATMENT

The treatment of mechanically damaged seed or the treatment of seed known to have low vigor or poor quality may result in reduced germination and/or reduction of seed and seedling vigor.
