Use only recommended rates -- lower amounts may not give the desired control. Higher amounts may cause seed injury. Seed should be well cured, dry and cleaned before treatment. For maximum benefits avoid deep seeding and exceptionally early sowing under poor growing conditions. Mix thoroughly with seed until the powder uniformly coats the seed.

d. Add the section heading **Physical and Chemical Hazards** with the following statements.

If maneb becomes wet in storage, its fungicidal effectiveness may be reduced and it may also product vapors which may be flammable. Keep away from flames and sparks.

- e. The term "disinfectant" is unacceptable since it is a misrepresentation of the pesticidal activity of maneb. A more acceptable term would be "fungicide".
