Harmful if inhaled. Causes skin irritation. Do not get in eyes, on skin or on clothing. Avoid breathing vapors". The rest of the text should appear as on your draft label.

- d. Because existing data shows that this formulation is toxicity category II for acute dermal toxicity and for dermal irritation, revise the Personal Protective Equipment section to specify coveralls over short sleeved shirt and short pants, waterproof gloves, and chemical resistant footwear. Also, because lindane is on the WPS active ingredient list as requiring an organic vapor removing respirator, replace the requirement for a dust/mist filtering respirator with "a respirator with either an organic vapor-removing cartridge with a prefilter approved for pesticides (MSHA/NIOSH approval number prefix TC-23C), or a canister approved for pesticides (MSHA/NIOSH approval number prefix TC-14G).".
 - e. In the Directions For Use, in the sentence "Lindane ST 40 may be tank mixed with other seed treatment fungicides.." delete "other", since lindane is not a fungicide.
 - f. Revise the beginning of the sentence "The Federal Food and Drug Administration has set official tolerances for certain pesticide residues." to read "The U.S. Environmental Protection Agency has set...".
 - g. Be sure to meet type size requirements for elements of the label with minimum type size requirements.
3. Submit three (3) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

Please note that the above acceptance is for the Basic Formula only. The Alternate Formula dated March 4, 1996 is not acceptable because the indicated level of the active ingredient in the source material is not correct. You may revise this declaration and the associated calculations and resubmit as an amendment for Agency approval.

STORAGE: Store in a cool place. Do not store in direct sunlight. Protect from freezing temperatures.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. Lindane ST 40 will protect seeds and seedlings against damage from wireworms and seed corn maggots.
