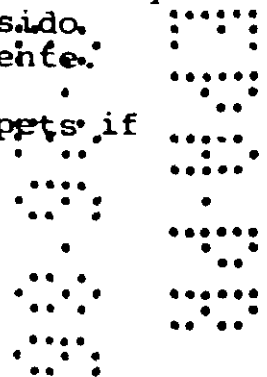

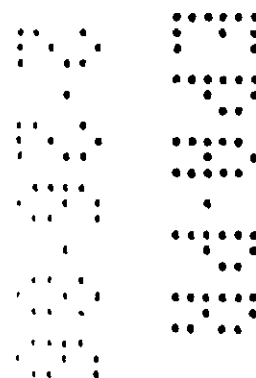

K-mart Snail and Slug Killer is a special preparation for the control of snails. K-mart Snail and Slug Killer attracts and kills snails and slugs with Metaldehyde. The presence of snails and slugs can be detected by their shiny mucous-like trail. They are night feeders and prefer damp, cool places in the ornamental garden, flowers, under boards or flower pots and around fences, hedges and bushes.

WARNING

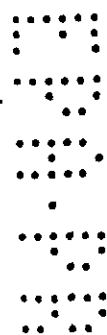

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling. Do not enter treated areas without protective clothing until application is complete.

Water area to be treated thoroughly. Broadcast K-mart Snail and Slug Killer late in the day in the areas likely to be infested. Apply to the soil and not directly on plants. Do not apply to edible parts of foliage. Scatter, do not leave in piles. In gardens and lawn areas, insure pellets are applied around the base of bedding plants and other low growing plants where snails and slugs hide. To avoid early damage to your garden, apply before snails and slugs appear at spring planting time.



Continuous watering and high temperatures cause this bait to gradually lose some of its effectiveness. Repeat applications every week to ten days during spring and summer months. Treatment every two weeks during fall and winter months is usually satisfactory. Repeated treatments provide control of new broods emerging during this period. Three baitings ten days apart usually gives control of new batch. Apply one pound of this product to each 1,200 square feet of area.

To control snails and slugs on the following vegetable and fruit crops, apply to soil surface around plants and trees. Do not contaminate edible parts of foliage.

**STORAGE AND DISPOSAL**

**Storage:** Store in original container in safe, dry place. Do not contaminate water, food or feed by storage or disposal.

**Disposal:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Completely empty bag into application equipment. Then dispose of empty bag in a sanitary landfill or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

**FRUIT CROPS:**

Apples, apricots, cherries, grapes, peaches, pears, nectarines, plums, avocados, blackberries, boysenberries, citrus, loganberries, raspberries and strawberries.

**VEGETABLES:**

Asparagus, beans, blackeyed peas, broccoli, brussel sprouts, cabbage, melons, carrots, cauliflower, corn, cucumbers, eggplants, endive, garlic, kale, kohlrabi, horseradish, leeks, lettuce, okra, onions, peas, peppers, potatoes, pumpkins, radishes, rutabagas, salsify, shallots, spinach, squash, swiss chard, tomatoes and turnips.

**FOR SNAILS AND SLUGS IN DICHONDRA, CLOVER AND GRASS LAWNS:**

Distribute pellets over entire lawn as necessary. One pound will cover 1,200 sq. ft.
