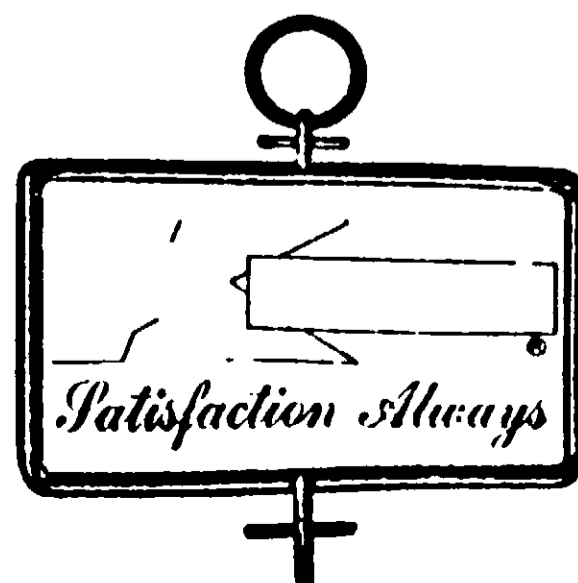

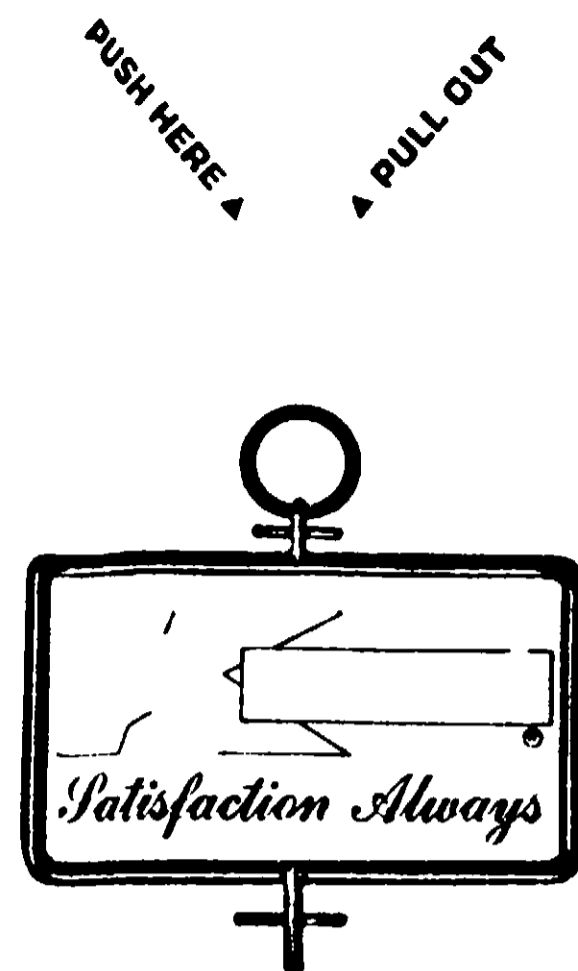

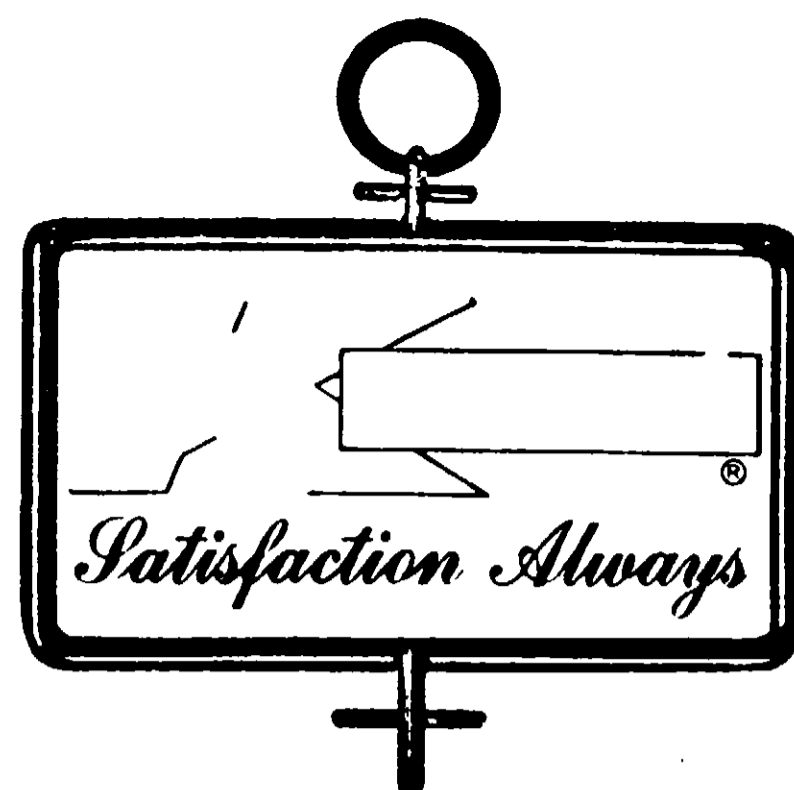

K-Mart Snail & Slug Killer is a special preparation for the control of snails. K-Mart Snail & Slug Killer attracts and kills snails and slugs with Metaldehyde. The presence of snails and slugs can be detected by their shiny mucuous-like trail. They are night feeders and prefer damp, cool places in the ornamental garden, flowers, under boards or flower pots and around fences, hedges and bushes.

**DIRECTIONS**

Water area to be treated thoroughly. Broadcast K-Mart Snail & Slug Killer late in the day in the areas likely to be infested. Apply to the soil and not directly on plants. Scatter, do not leave in piles.

Continuous watering and high temperatures cause this bait to gradually lose some of its effectiveness. Repeat applications every week or ten days during spring and summer months. Treatment every two weeks during fall and winter months is usually satisfactory. Repeated treatments provide control of new broods emerging during this period. Three baitings ten days apart, usually gives control of new hatch.

Apply one pound of meal to each 250-300 square feet.

**WARNING**

MAY BE FATAL IF SWALLOWED. Harmful dust. Avoid inhalation of dust. Avoid contact with skin, eyes, and clothing. Avoid food contamination. Wash hands with soap and water after using.
