Swift Chinch Bug Killer is a water emulsifiable concentrate designed to kill chinch bugs and sod webworms. It mixes readily with water and is especially designed for use with hose sprayers.

Garden hose sprayers such as the Vigoro Lawn Gun that are gauged to apply 15 to 20 gallons to empty one quart jar will provide good coverage and penetration. Other similar type sprayers will do a satisfactory job.

DIRECTIONS FOR USE ON LAWNS

It is very important to use according to directions. Otherwise serious injury may occur to plants or persons.

CHINCH BUGS: Apply 1¼ quarts of Swift Chinch Bug Killer in 30 to 40 gallons of water to 550 square feet of lawn (50' x 11'). Be sure the spray penetrates heavily matted turf to obtain maximum kill. Thorough watering before application is helpful. Do not mow lawn for 24 hours after use.

SOD WEBWORMS: Use 1¼ quarts of Swift Chinch Bug Killer on heavily matted lawns or 1 quart on thinner sod. Allow two days for good kill. Examine lawn periodically for new broods. Spray before injury shows up in lawn. Do not mow lawn for 24 hours after use.
