DIRECTIONS FOR USE

For Southern Turf Grasses (Bermuda, Centipede, Fescue, Zoysia, St. Augustine, and Bahia) To control Poa Annua, smooth crab grass, hairy crabgrass, goose grass (silver crabgrass), water grass (barnyard grass), yellow and green foxtail. Apply broadcast at a rate 600 pounds per acre (1 1/2 pounds per 1000 square feet) prior to germination of weed grasses as the material will not control established weeds.

Do not apply to newly seeded areas. Do not apply in the spring to lawns planted the previous fall. Do not apply to newly sprigged areas until the turfs are well established. Do not reseed within 42 days after application.

CAUTION

Keep out of reach of children. Avoid prolonged or repeated contact with skin or inhalation of dust. Wash thoroughly after handling. Keep away from feed or foodstuffs.
