DIRECTION FOR USE GENERAL CLASSIFICATION

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Add two ounces per gallon water

Apply MINT QUAT to floors, walls and other hard surfaces such as tables, chairs, and bedframes with a cloth or mop.

At two ounces per gallon use level, MINT QUAT is effective against *Staphylococcus aureus*, *Salmonella choleraesuis*, *Escherichia coli*, and *Trichophyton interdigitale*, the athlete's foot fungus. Germicidal performance against the first three organisms has been confirmed by the AOAC Use-Dilution Test. Fungicidal performance against *T. interdigitale* was determined by the AOAC Fungicidal Test.

*At two ounces per gallon use level, MINT QUAT is virucidal against Herpes Simplex (a member of the virus family that causes infectious mononucleosis), Vaccinia (representative of the pox viruses), and Influenza A₂, as represented by the Strains commonly called the Hong Kong Flu and the London Flu Virus, on inanimate environmental surfaces.

Note: this product is not effective against *Ps. aeruginosa* at this use level.

For sanitizing add one ounce per gallon of water.

Use MINT QUAT for sanitizing and cleaning utensils, equipment, and other hard surfaces. When sanitizing food processing equipment and utensils and food contact surfaces, a potable water rinse is required.

STORAGE AND DISPOSAL

STORAGE

Do not contaminate water, food or feed by storage or disposal. Do not store on side. Avoid creasing or impacting of side walls.

PESTICIDE DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Wastes resulting from the use of this product may be disposed of on site, or at an approved waste disposal facility.

Do not reuse empty bottle. Wrap bottle and put in trash.

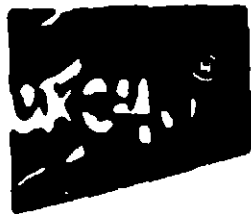
STATEMENT OF PRACTICAL TREATMENT Precautionary Statements —
