DIRECTIONS FOR USE

To be most effective, the dust should be applied before the insects become numerous and diseases are apparent. Apply dust evenly to all plant surfaces at 7 to 14 day intervals. During periods of new growth and humid spells, apply at 4 to 5 day intervals.

FLOWER INSECTS CONTROLLED

Aphids, Red Spider Mites, Japanese Beetles, Rose Leafhoppers, Leaf Rollers, Rose Slugs on GLADIOLI, DAHLIAS, ASTERS, CHRYSANTHEMUMS, SNAPDRAGONS.

ORNAMENTAL INSECTS CONTROLLED

Aphids, Japanese Beetles, Lacebugs, Spider Mites, Euonymus Scale Crawlers, Boxwood Leaf Miners, Bagworms on RHODODENDRONS, AZALEAS, JUNIPERS, EUONYMUS, BOXWOOD, and LILAC.

DISEASES CONTROLLED

Black Spot and Powdery Mildew on ROSES, Septoria Leaf Spot on CHRYSANTHEMUMS, Didymellina Leaf Spot on IRIS, Rust and Alternaria Leaf Spot on CARNATIONS, Alternaria Leaf Spot, Powdery Mildew, and Anthracnose on MARIGOLDS, ASTERS, PHLOX, and SNAPDRAGONS.

Do not use on certain ferns including Boston, Maidenhair and Pteris, as well as on some species of Crassula. Do not use on Boston Ivy. Do not use on Japanese Maple.

STORAGE AND DISPOSAL

STORAGE: Store unused material, in original container only, in a locked storage area out of the reach of children and animals. Keep container tightly closed.

DISPOSAL: Do not reuse empty container. Securely wrap in several layers of newspaper and discard in trash. Rinse thoroughly before discarding in trash.

On 4 lb. bags the STORAGE AND DISPOSAL statements will read:

STORAGE AND DISPOSAL

STORAGE: Store unused material, in original container only, in a locked storage area out of the reach of children and animals.

DISPOSAL: Do not reuse empty bag. Securely wrap in several layers of newspaper and discard in trash.

On 25 lb. bags, or larger, the STORAGE AND DISPOSAL statements will read:

STORAGE AND DISPOSAL (12 point type)

STORAGE: Store unused material in original container only, in a locked storage area out of the reach of children and animals.
