This product contains organic phosphate and chlorinated hydrocarbon pesticides. Poisoning symptoms may be related to both pesticides. IF INHALED: Remove victim to fresh air. IF ON SKIN: Remove contaminated clothing and wash affected area with soap and water. Launder clothing before reusing. IF IN EYES: Flush with plenty of water. NOTE TO PHYSICIAN: Atropine by injection is antidotal for organic phosphate poisoning.

DIRECTIONS FOR USE

It is a Violation of Federal Law to use this product in a manner inconsistent with its labeling.

TO CONTROL: Horn Flies, apply 2 ounces (4 Tablespoons) per animal. Rub well on back and neck of each animal to insure that the material is worked down beneath the hair. Repeat application every 3 weeks if necessary. TO CONTROL: Lice, make a thorough application on Swine, Sheep and Beef Cattle, work the dust into the hair. Repeat application as necessary.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Store in closed original container in a cool, dry place, away from children or domestic animals. Avoid excessive heat. Do not reuse empty container. Securely wrap in several layers of newspapers and discard in trash.
