DIRECTIONS FOR USE

For Use in Fogging Machines for Spraying Dairy Barns, Horse Barns, and Other Livestock Buildings: Close windows and fog area using two ounces per 1000 cubic feet. Keep windows closed for 10 minutes after fogging. During first applications, concentrate on breeding places (cracks, crevices, corners). Repeat fogging as often as necessary. Animals which have received a direct application should not be fogged within 8 hours of that treatment.

For Face Fly Control: Spray animal's head thoroughly covering muzzle, poll, forehead and sides of face. Do not apply more than two ounces daily to entire animal.
