

# ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish, aquatic invertebrates, and aquatic life stages of amphibians. Do not apply directly to water or wetlands (i.e., swamps, bogs, marshes and potholes). ## STATEMENT OF PRACTICAL TREATMENT

This product contains organic phosphate and chlorinated hydorcarbon pesticides. Poisoning symptoms may be related to both pesticides. IF INHALED: Remove victim to fresh air. IF ON SKIN: Remove contaminated clothing and wash affected area with soap and water. Launder clothing before reusing. IF IN EYES: Flush with plenty of water. NOTE TO PHYSICIAN: Atropine by injection is antidotal for organic phosphate poisoning.

## DIRECTIONS FOR USE

It is a Violation of Federal Law to use this product in a manner inconsistent with its labeling.

To control lice on non-lactacting Dairy Cattle, Swine, and Beef Cattle, treat animals thoroughly. Repeat application as necessary.

Do not apply to dairy animals during lactating or within 2 weeks of freshening. Do not apply to animals being furnished for slaughter.

To control Horn Flies, apply 2 oz. (4 Tablespoons) per animal. Rub well on back and neck of each animal to insure that the material is worked down beneath the hair. Repeat application every three weeks if necessary.

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. STORAGE: Store unused materiall, in original container only, in a locked, drv, storage area out of reach of children and animals. Keep container tightly closed. DISPOSAL: Do not reuse container. Securely wrap in several layers of newspaper and discard in trash.
