



**SPONGE-ON" FLY KILLER





For Horses

KILLS and REPELS: Horse Flies, Stable Flies, House Flies, Face Flies, Horn Flies, Gnats and Mosquitoes

Always mix with water, then sponge-on

NET CONTENTS: 1 QUART

ROCKLAND "SPONGE-ON" FLY KILLER is esspecially formulated for mixing with water and sponging on horses.

Mix 1 pint of ROCKLAND "SPONGE-ON" FLY KILLER with 9 pints of water to make 1½ gallons, or 1 quart with 9 quarts of water to make 2½ gallons. Stir before using Sponge on at rate of 1 pint to 1 quart of mixed solution per animal, depending on the size of the animal.

Sponge mixed solution on portions of the hair coat in the region of the ears, neck, back (except under saddle), belly and legs, as last step in grooming procedure or when flies are troublesome.

Store unused mixed solution in closed container. Stir before next use.

For Stable Flies, House Flies, Horse Flies, Deer Flies and Face Flies: Apply at 3 day intervals or as necessary to give continued protection.

For Horn Flies, Mosquitoes and Gnats: Apply at 3 day intervals or as necessary.

DILUTION TABLE FOR SMALL AMOUNTS

Mix 3 tablespoons with sufficient water to make 1 pint.

Mix 3 czs. with sufficient water to make 1 qt.

Mix 12 ozs. with sufficient water to make 1 gal.

A pint pottle of ROCKLAND "SPONGE-ON" FLY KILLER is sufficient to treat up to 10 horses or one horse for a month at 3 day intervals.
