Dear Ms. Lemm,

We have reviewed the subject labeling, which was submitted for the purpose of adding a Statement of Practical Treatment section to the label. This labeling, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

1. Add, as the first sentence,

"Harmful if swallowed."

to the "HAZARDS TO HUMANS" section in the Precautionary Statements.

2. Move the sentence

"Do not contaminate food and feedstuffs."

to the end of the "HAZARDS TO HUMANS" section, placing it directly after "Avoid contact with skin and eyes."

3. Change the title of the "HAZARDS TO HUMANS" section in the Precautionary Statements to "HAZARDS TO HUMANS AND DOMESTIC ANIMALS".

4. Add a new section to the Precautionary Statements. Title it "ENVIRONMENTAL HAZARDS" and place it directly below the "STATEMENT OF PRACTICAL TREATMENT" section. The wording of this section must exactly conform to the following text:

"This product is toxic to fish and other invertebrates. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes."

5. Add an additional new section to the Precautionary Statements. Title it "PHYSICAL OR CHEMICAL HAZARDS" and place it directly below the new "ENVIRONMENTAL HAZARDS" section in item 4. above. The wording of this section must exactly conform to the following text:

"Do not use or store near heat or open flame."

6. Change the wording of the "STORAGE:" section to exactly conform to the following text:

"Store unused material, in the original container only, in a cool dry area that is inaccessible to children and pets and away from heat and open flame."

7. Add the EPA Establishment Number.
8. Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the labeling is enclosed for your records.

PRECAUTIONARY STATEMENTS:

HAZARDS TO HUMANS: CAUTION: Do not contaminate food and feedstuffs. Use gloves if applying by hand. Avoid contact with skin and eyes. ~~If on skin, wash with soap and water.~~

STATEMENT OF PRACTICAL TREATMENT:

IF ON SKIN: Wash with soap and water until no odor remains. Wash clothing before reuse. **IF IN EYES:** Flush with plenty of water. If irritation persists, consult a physician. **IF SWALLOWED:** Drink at least two glasses of water and induce vomiting unless victim is unconscious. Obtain medical assistance. Small amounts which accidentally enter mouth should be rinsed out until taste of it is gone. **IF INHALED:** Remove victim to fresh air.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labelling.

To prevent your pet, or stray animals, from soiling flower beds, areas of lawn, trees, shrubbery or evergreens: Apply these granules by hand or with a fertilizer spreader to borders of flower beds, or to ground and grass around the base of shrubs, trees and evergreens, or to patches of lawn you wish to protect. Sprinkle enough to cover the treated areas lightly (about 4 pounds per 1000 sq ft., or 1-2 cupfuls for 100 sq ft.) Repeat applications until the undesirable animal habits are broken. Repeat applications after rains.

To protect garbage cans and rubbish containers from disturbance by dogs and cats, sprinkle the ground or floor about them liberally with granules. Repeat as necessary.

Stray animals are frequently attracted to areas where urine or feces have been deposited. First, remove any droppings then apply these granules. Do not apply these granules directly to foliage of shrubs or to ornamental, soft-bodied plants. Do not apply on or near food crops.

General Information: The most effective control for a pet is the sharply spoken word backed up with disciplinary action. For most effective results on pets, this repellent product should be used in conjunction with training.

NOTE: This product is not likely to break the established urination patterns of dogs, unless used as a training aid.

STORAGE AND DISPOSAL

STORAGE Store unused material, in original container only, in a locked storage area out of reach of children and animals.

DISPOSAL Do not reuse empty container. Securely wrap in several layers of newspaper and discard in trash.
